## 59/18-19 Public Speaking

(a) Public Speaking

Residents would like to do some clearance on the footpath that runs along the allotments

A report has been received that undergrowth from Manor Road Park is taking up pavement on Recreation Road and Manor Road.

Borough Councillor John Burrows reported that there is a new grounds maintenance plan in Brimington and Hollingwood, this should help improve the service.

A new planning application has been received for the land north-west of Northmoor View, the number of houses has been reduced from 300 to 150, but it is obvious from the re-submission documentation that there is serious intent to develop the land. The major change to the application is that all access to and from the site would be on the Chesterfield Road side, so Manor Road would not be so affected. However the access onto Chesterfield Road will be via traffic lights, which will further increase the congestion on this busy stretch during peak times.

A petition has been signed by 623 people and many representations against the proposal have again been received by the Planning Department at Chesterfield Borough Council.

Members of the public highlighted their major objections to the application; these included the effect on wildlife and the loss of a green field site. The high levels on pollution in the area and in particular on Church Street, in conjunction a question was raised about the percentage of people in Brimington with respiratory diseases and how this measured against the national average. The difficulty in getting a GP appointment and that the local surgeries do not have capacity for more patients. The issue with so many more school places that would be required.

Residents were advised that they were entitled to be at the Planning Committee and that they would be allowed 3 minutes to speak.

### 65/18-19 Planning Applications

CHE/18/00436/REM - Land to the Rear of 292 Manor Road, Brimington - Reserved matters application for CHE/15/00344/OUT - erection of 26 dwellings (application dated 16 July 2018, extension requested for Parish Council response to 12 September 2018, but only granted to 16 August 2018)

**Resolved:** To comment to the Planning Authority that it was understood that both water authorities have previously stated that the drainage system on Manor Road is not able to take any further dwellings on the current system; and to ask that this is considered when determining the application.

(b) CHE/18/00527/REM1 – Land North – East of Sainsbury's Roundabout , Rother Way, Brimington - Variation of condition 1 (alterations to approved drawings) of CHE/17/00685/REM – for residential development of 120 dwellings to allow a minor layout amendment

Resolved: To raise no objection

(c) CHE/18/00532/OUT – Land to the North West Of Northmoor View, Brimington – Outline Application for residential development (of up to 150 dwellings) and associated access works – Resubmission of CHE/16/00614/OUT (Outline application for proposed housing development with all matters reserved except the access – additional information received – heritage impact assessment and geographical survey received on 19/04/2017; and transport assessment addendum rec'd on 02/05/2017) (extension granted for Parish Council response to 12 September 2018).

**Resolved**: It was unanimously resolved to object to the planning application on the following five grounds:

- i) This is a valuable green field site in the village, full of wildlife, and it is strongly felt that development should be concentrated on the existing brown field sites
- ii) There are major concerns over the increase in traffic congestion that this application would cause in Brimington for both residents and people travelling on the A619
- iii) There are major health concerns over any potential increase in pollution in an area which already has an unacceptably high level of pollution
- iv) There is a concern about any further strain being put on GP surgeries, when it is already problematic for residents to get appointments
- v) There are concerns about the provision of school places for children from an additional 150 households.

Post meeting note, the doctors surgeries in Brimington have been asked if they are able to provide figures with regards to the number of people in Brimington who are suffering with respiratory diseases and how this compares to the national average.

## 66/18-19 Meeting Reports

(a) Community Centre
