The Crime Figures for March 2021 are 80, compared to 42 for the same period in 2020 and 42 in 2019. The crimes include 23 incidents of anti-social behaviour, 6 criminal damage, 31 violence, 7 public order, 2 theft of or from vehicles, 4 other theft, 1 burglary, 4 other crime, 1 shoplifting and 1 drugs.

The Crime Figures for April 2021 are 93, compared to 84 for the same period in 2020 and 52 in 2019. The crimes include 33 incidents of anti-social behaviour, 10 criminal damage, 34 violence, 4 public order, 2 other theft, 1 burglary, 7 other crime, 2 drugs.
